1. The risk of injury from the activities involved in this program may be significant and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury does exist, and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS on my own behalf and on behalf of the minor(s) for whom I am responsible, both known and unknown, and assume full responsibility for my participation; and;
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest CPC representative immediately; and
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS, the CPC, its officers, officials, agents, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), from any and all claims whatsoever, including disability and/or death, or loss or damage to person or property whether now known or arising in the future; and
5. In the event that a claim is brought by Participant or Releasee against the other, the defendant shall be able to recover any and all attorney's fees if incurred in successfully defending against such claim; and
6. I hereby certify that I have authority to enter this agreement on behalf of the minor(s) and agree to be bound by all terms and conditions of this agreement. I further agree to hold harmless and indemnify CPC, its agents and/or employees, for any and all claims whatsoever brought by the minor and all claims whatsoever brought by a third party arising in connection with the minor.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND AGREE THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT.
